Dear Contestant,

This is a recap of how finals night will unfold. As the pageant progresses past preliminary competition, the field of contestants will be narrowed to our group of semifinalists, and then 5 finalists. The semifinalists will compete in Swimsuit (MISS) or Athletic Wear (TEEN) and Evening Gown Competitions in order to narrow the field to 5 finalists. The 5 final contestants will then participate in an on-stage interview competition. Each of the 5 contestants will receive 2 questions.

First, they will receive a "contestant question." Each of you will need to submit a question that you would like to ask of a top-5 finalist. You should bring your question to registration and turn it in then. Be sure to include your name and title on your question. The staff will review the questions and select 5 in each age division.

On final night, each of the final three will draw one question to answer. You will be told which of your fellow contestants submitted the question. If you happen to choose your own question, simply select another. Please give due consideration to the question you ask. This is your chance to participate in determining what questions the top-5 will have to answer.

The second question to be asked will be the traditional "judge's question." Each of the five judges will submit a random question, and each of the top-5 will randomly draw one of the judges' questions that they will then answer.

This process will be explained again during orientation, so if you have questions feel free to ask for clarification at that time.
